- **Grade Improvement** One session must be fulfilled and students can earn a maximum increase of 2 letter grades.
- Math Readiness Audit (NO Credit given) this only <u>prepares</u> the student for their upcoming class in the fall.
- Non-TCS students may take classes, but it is UP TO THEIR SCHOOL if they will earn credit.
- A 10% discount will be applied for each additional sibling.
- Full payment will be posted to your *FACTS* account. Refunds will only be granted 7 days before the start of each class.
